GENERAL NOTICE

Therefore, all shops and commercial establishments are hereby directed not to display their goods and wares outside their premises with immediate effect failing which the same shall be removed by SMB at their cost to be followed by a legal action, which may also result in the suspension/revocation of the Business License.
