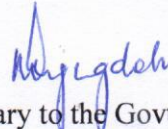

No.LE&SD.20/2023/72: In exercise of the powers conferred under **Section 62** and in pursuance of **Section 12** of the Building & Other Construction Workers' (Regulation of Employment & Conditions of Service) Act, 1996, the Government of Meghalaya hereby directs all Contractors applying for a Tender for any construction work to either mandatorily employ only those workers registered with the Meghalaya Building & Other Construction Workers' Welfare Board or to mandatorily register their workers with the Meghalaya Building & Other Construction Workers' Welfare Board as a **Pre Tender Condition** and to submit proof of such registrations to the concerned Line Departments. All line Departments having works involving building & other construction workers are to ensure strict compliance.

This supersedes Notification No. LBG 73/12/Pt II /453 dated 30th May, 2018

This Notification shall come into force with effect from the date of publication in the Official Gazette and until further orders.

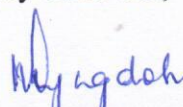
